Report of the Treasurer: Renee said she'll make this real quick. We still have money and the tax bill is coming due soon.

Linda Hudak said the minutes from the last meeting were in the Chatterbarks and if you ever need to look up important information you will find it there.

Report of the Directors: Linda asked Pat for an update on the Building. Pat is trying to get little repairs done so if you see anything wrong or something that is broken or needs to be replaced please bring it to our attention. Renee is reminding us that our Scent trial is coming up this weekend. Thursday they will be setting up after 3pm. Friday is the Masters category. She still needs about 8 helpers. It will be a short day and there will be snacks available. Saturday will be really busy and there will be two trials going on. We will have lots of jobs for volunteers. Please come by 8am. Linda asked Terry if she had something to say about the banquet. It was voted at the last meeting to have catered food at the training center. Pat was wondering if we would be able to sit at tables to eat or if we would like to scale it back. The membership voted for Olive Garden for the catered food. Terry's price quotes were relatively reasonable compared to other previous quotes from restaurants. They are looking at the date of Dec. 6, 2021. Terry and Claire will decorate. At the November meeting there will be a vote on the final food selections.

Ralph mentioned that there were two more police dogs shot over the weekend. They are both doing great. Ralph has raised 4K to help with expenses of a project to honor dogs that have been killed in the line of duty. The County training area on Tiger Bay Rd. wants a sitting GSD bronze statue of Foster. The estimated cost of the statue is \$7,500. Ralph's project to help victims of Hurricane Ida is underway. They have a wish list for items and have been collecting items for some time. Ralph is getting a lot for his money because he shops at the Dollar Tree. They have even donated items to him. When they're ready they will rent a truck to take the items to Louisiana. Ralph has also raised \$750 through a go fund me page for a kids camp helping children that have life threatening disabilities.

Linda Campagna is getting ready to start Canine Musical Freestyle Dance classes in two weeks on Sunday at 2pm. You don't have to know how to dance. We can train any dog and any person to do fun routines to music. The dogs learn lots of moves and tricks and get lots of treats. There is no prerequisite for this class which is 7 weeks long. When we didn't have covid we would do little demos in the community and once a year we would have a big show at the Ormond Beach Performing Arts Center which is free to the public. Give Linda Campagna a call for more information. She doesn't get texting.

Linda Hudak is looking to get a nominating committee together. Please e-mail her and let her know if you are interested in being on the committee for this year.

Patty Mills is taking over the new membership roster. Linda Brendsinger wants us to know that when she sends out mass e-mails if you intend to reply to the person that originated the e-mail please don't do an automatic reply. Anna said the Sniff and Go went really good and they had 90 runs.

Linda wants to know if we will have another Scent trial next year in September. Renee would like to have a 2nd trial in April if possible.

Michelle Lemole is here to talk to us about Dock Diving. She has been a club member for 24 years. She also teaches Basic Obedience and Agility. Her dogs do Dock Diving and are registered with NADD which is North American Diving Dogs Association. The fee is only \$35 per dog. There are different types of retrieves and the dogs have to be 6 months old to compete. It is a sport which involves either you throwing something into the water for your dog to retrieve or something your dog will retrieve out of the air which is called air retrieve or a speed retrieve which is called hydro dash. First we have distance jumping and your dog is judged on how far they jump. The dog is judged by where they land in the water by the base of their tail. Categories are Novice, Novice Senior, Master and Elite. Use colors on items thrown like yellow, blue, and orange which looks like gold to a dog. Air Retrieve is when they run and then launch at the bumper and pull it off the item that's it's attached to with clips. This sport is full of fun times for you and your dogs. Hydro dash has the bumper close to the water and it is timed. The Pools are 40 or 45 feet. The Dock is 2 feet from the water. It takes time and effort to teach them to jump. Michelle discussed different ways to do this. Thanks to Michelle for such an interesting presentation and showing us pictures and types of bumpers. If you have more questions please call Michelle. She has offered to come back again to discuss more about Dock Diving at another meeting if we would like her to. Renee motioned to adjourn...Claire seconded the motion.
