Excerpt from the standing rules:

TITLE AWARDS

- A. Upon receiving a dog's title
- 1. A member may purchase a plaque bearing dog's registered name and call name
- B. All titles received by same dog may be purchased and will be printed on hanging tags with title and date earned
- C. All plaques and tags must be submitted to the Trophy Chairperson in writing on or before the closing date (no exceptions), to be determined by the Awards Chairman.
- D. A proof will be sent before ordering to be sure spellings and awards are correct, and must be returned to Chairman with approval.
- E. All plaques and tags must be paid for in advance of order.

Old Business:

Club Shirts: Anyone who needs a club shirt should contact Jan. Her card is at the front desk. Anyone needing a shirt to steward at our trial should contact her as soon as possible to arrange to get the correct size in time for the trial.

Social Media: Pat announced the ads and videos are doing well. Joan announced that callers report seeing us on Facebook. October was Adopt A Shelter theme, November will probably involve feeding the wrong foods to your dog at Thanksgiving time and December will involve why a puppy is not always the best surprise Christmas gift.

Scentwork: We will be looking in to installing a curtain or barrier between the ring 4 and puppy ring. Something will be needed to prevent exhibitors who are waiting their turn from seeing the scent work area during our January trial. Ralph cautioned that we need to be able to remove anything that is used so that the ring 4 can be extended into the puppy area for obedience or Rally trials.

Obedience and RallyTrials: are December 8, 9 and 10, 2017 (the August minutes listed incorrect dates.) Ralph reported we still need workers and more ring stewards for these trials. He explained that we will have four rings for the first time in the building. The trial will be three days so that we can demonstrate to the AKC that we are capable of holding a 3 day event and therefore also be eligible for consideration as a venue for a national event. Marge has ribbons for the trial including those required for the new Rally classes. It is not expected that anyone will have enough points to qualify for the ROC at our trial, so that ribbon will be ordered for the July, 2018 trial.

Class Schedule: Barb explained that the class schedule is not listed on the calendar page on our website. It is published as a pdf on a number of pages including the home page. The first occurrence of the file is accessed by clicking on the words 'Current Class Schedule' about in the middle of the page.

Building Cleaning: Pat reported we had a most excellent turnout. It only took about an hour and a half probably because so many brought their own cleaning supplies so we did not have to take turns with the vacuum, etc. Thank you everyone. The next day is in December. Check Chatterbarks for the date please. Anyone who cannot make that date, can arrange to do cleaning on a day when they are in the building for class. A question came up regarding cleaning agility equipment. Pat and Janet will discuss this topic later.

Tracking Test: will be in January. Ralph has items for sale and a raffle to raise money for the test.

Agility Trials: will be January 19, 20 and 21, 2018 (new AKC week.) We need workers and new equipment to meet the new AKC rules.

Agility Classes: will start a week later because of Irma's flood at the training arena.

New Business:

Scentwork: Reneé announced we will hold a Sniff n Go on November 18. We'll need a timer and other workers. This event will help us prepare for our first Scentwork trial on January 6. Lind will hold an additional scentwork class on Friday evenings at 7PM for those who cannot attend the Wednesday afternoon class.

Public Relations: Pat announced Newman Veterinary Center on 92 east of DeLand has requested we do a demo at an event they are having October 21. Sandy and possibly Dana and Kelly will also represent our club there.

C Match: The September 9th match was cancelled due to the Irma evacuation. The next C Match will be November 11. LindaS reported we need judges and will allow treats and toys in the ring. Registration will run from 8 to 1PM and judging will start at 8:30. We'll have both obedience and rally and the originally scheduled C Match will be held December 2, 2017.

Awards Banquet: JoanC announced the dinner will be Monday evening, December 11th at the Daytona Beach Kennel Club. The fee is \$11 for working members and \$22 for non-working members and for guests. There will be a gift exchange. The dog oriented gifts can be for dog or human and are usually around \$10. Bring a wrapped gift, take a number and pick a gift when your number is called.

Rain water under front door: There is a missing piece of weather seal under the front door that allows windblown water to flow into the building. Reneé will look in to purchasing an absorbent mat to alleviate the problems caused by the water.

Annual Contributions: It was pointed out that we did not disperse any donations last year and that we need to decide about this year's donations. Ideas will be discussed at the November meeting.

Shirley motioned we adjourn at 7:56PM and JoanC seconded.

Information about the upcoming Obedience & Rally Trials by Ralph Orlando Trial Chairman

Our fast approaching Obedience and Rally trial will be hear before you know it. The three day trial is December 8-10 (F,S,S). The December trial has been two days until this one and then only Novice obedience and all Rally. This one is now all classes of obedience and all rally and for all three days. That means about 50 energetic volunteers needed to cover the 3 days. Right now we are about 10 short of the manpower needs and I have no doubt in fulfilling the need as sign ups come in.

For those of you new to stewarding duties it would benefit a great deal if you could help out at the 2 C- matches coming up. Match 1 is on Nov. 11 and the 2nd is on Dec.2 just a week before the trial. Judges will tweak the steward duties by a little bit but learning at a match will get you very close.

Then on Dec. 3rd is the last TC cleaning of the year and is in preparation for a clean house for the trial. On Thursday December 7 we will be setting up for the trial. Rings and gating will be checked and set, chairs typically stacked along the front windows for guests to use as needed, any private chairs and crates removed for members not showing, raffle and ribbon tables set up, ringside table tables set up with trial supplies at each table. Puppy room toys and equipment will have to be moved into the agility room and neatly stacked so as to leave room for any additional crating needs for exhibitors. There is more but you get the idea. This is a good size undertaking. We will also be using 4 show rings this time so crating normally in ring 4 will not be available. After the trial ends on Sunday the process is reversed.

I have been asked by stewards what time is show up time. Typically :45 before start time is the answer. Most judges will arrive 1 hour or so before 1st dog in. They will often need help from their stewards in getting their rings set. They will also brief the stewards to clarify how they want to run their class. Rally stewards will help with placing the sign holders and signs.

Needed also will be a few large coolers for bottled water kept on ice. Snack food for stewards will be on a office table and a dining tables for judges will also be set up there. Food for stewards/staff will be provided by Greg's Seafood and BBQ and meal tickets will be given to these workers.

Next question is how many can come on Thursday Dec. 7th to get all of this done (the need will be determined by what is left to do after the Sunday before clean up). I think the best plan would be to get a lot of the heavy lifting done on cleaning day Dec. 3 when there should be a large work crew leaving less to do on Dec. 7th.
