- C. All plaques and tags must be submitted to the Trophy Chairperson in writing on or before the closing date (no exceptions), to be determined by the Awards Chairman.
- D. A proof will be sent before ordering to be sure spellings and awards are correct, and must be returned to Chairman with approval.

Tonight, club members in attendance voted on additional wording in the bi-laws [Article II., Section 1, Club Meetings] as of 10/12/2020 to allow the club to hold virtual meetings in the future as approved by AKC. Renee Johnson opened by reading the following:

The newest entity of the bi-laws to read: 'Meetings of the club shall be held the 2nd Monday of each month within the Greater Daytona Beach area at such hour and place as may be designated by the Board of Directors. Notice shall be electronically mailed to the entire membership by the Secretary at least 5 days & not

more than 10 days prior to the meeting. <u>Meetings may be held tele-conference, video conference & virtual electronic.'</u>

President Linda Hudak reminded the membership in attendance this is what we are voting on because AKC has approved, because of Covid, to give us the ability and their 'OK' to be stated in our bi-laws to be able to hold our meetings virtually in case anything were to come up in the future; to have this in place.

Joan Costello made a motion to accept what was read. Second by Pat Dean.

By a show of hands (counted out loud by club Secretary): of 23 members in attendance there were **20 (Yes/Ayes)**; None opposed (nays); 3 non- votes. President Linda Hudak declared vote complete; approved.

Following the completion of the vote,

Sandy Baily introduced 2 officers from the Daytona Beach K-9 unit to discuss the plans for the construction of their new 3-bay kennel. The membership learned about the Challenge Coin medallion that they are selling to raise money for the kennel project. Members in attendance that wanted to show support were able to donate \$20 and had Sandy add their names to a list to receive a medallion at a later time. The discussion was then followed by a demonstration from the officers and their 2 canines.

Meeting was adjourned at the conclusion of the demonstration at 7:58pm

#### **Agility Trial Volunteers Needed**

Trial Set Up: Thursday, January 21st @ 9 am

Trial: January 22, 23 and 24th starting @ 7:15 am till late afternoon

Due to the Covid-19 virus we are not able to utilize groups from local schools to assist us with the Agility Trial. We are in need of Volunteers to make this Trial a success. On Friday we have a total of 10 rings we need help with. On Saturday it is 11 rings. On Sunday it is 7 rings.

Whether you can work all weekend, a few hours each day or even one class your help will be greatly appreciated. Responsible teenagers are encouraged to help as well so if you know some teens that would like to help we would love to have them.

The **Inside Ring Crew** has one of the easiest jobs and is closest to the action! Watching the amazing dogs and handlers running the course makes the day go by quickly.

#### **Inside Ring Crew Consists Of:**

- **3 Bar Setters** who are responsible for putting dropped bars back in place, changing the height for jumps and the pause table.
- 1 Leash Runner who is responsible for moving the leash from the ring entrance to the exit.

The **Outside Ring Crew** is not a difficult job, but does require a bit of skill to do the jobs. You will still be able to enjoy the action in the ring, but at times your focus will be on the job at hand.

#### **Outside Ring Crew Consists Of:**

- Gate Steward who is responsible for checking in the dogs before the ring starts, dealing with ring conflicts and calling out the running order once the judge is ready to begin. The Gate Steward is NOT responsible for hunting down the next dog in line. It is the Handlers responsibility to arrive at the gate in time for their scheduled run.
- Sheet Runner who is responsible for taking the score sheets to the Trial Secretary.
- Scribe who is responsible for marking down the Judge's calls during each of the runs.
- Timer who is responsible for signaling the running team to Go/Ready, making sure that the timer starts once the dog passes over the timer eyes, and to manually track the time for those choosing to do a Fix N Go in the ring.

**Course Builders** are needed to work with our **Chief Course Builder**. This job is physically demanding but teamwork lightens the load.
