### *President's*

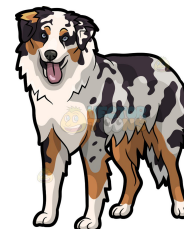
Hello Club Members,

Meeting was called to order by: President Linda Hudak at 7:05pm

Sign in sheet circulated -26 members present; 2 guests.

*\*Minutes of the last meeting were in previous month's Chatterbarks but there is a delay in publishing Chatterbarks while Joan recuperates- December minutes from the awards get-together were read at the meeting.*

-Report of the Secretary: New member: Kathy Busch of Port Orange (SM).

-Report of the Treasurer: December Club made approx. \$1,000.00 from the Obed/Rally trial. There were dues paid so the online Stripe account has about \$2900 in it. The various checking/savings accounts are in good standing for now and it appears we came in at approx. \$7,000.00 for the year.

Report by The Committee Chairperson for the Nominating Committee, Shirley Shalansky: Up for nomination (2021 positions): **for President Linda Hudak (returning), Vice President Kris Davenport (returning), Secretary (New) Linda Campagna, Treasurer (New) Todd Traster and returning Treasurer, Renee Johnson. On the Official board: Claire Israelson (returning), Pat Mozdon (returning) and Linda Brendlinger (New).** Linda Hudak opened the floor for any other nominations. None presented. Linda Hudak requested we move forward with a vote on the named nominees submitted by the committee for 2021 nominations and asked for a vote on the slate as presented: Motion to vote by Pat Mozden; Second by Janet Berry. All in favor 23 (Ayes)-none opposed(nays). motion carries. Linda Hudak announced then 'these will be the new officers and members at large for 2021' and she thanked the Chairperson and the Nominating Committee.

Following the completion of the vote, Linda Hudak asked for a quick summary on what classes will be starting or have just started- Renee said there was a puppy class and Basic; Class schedule is being worked on. Renee reminded the attendees that we need the payment for classes beforehand or we cannot hold a spot and it takes about 5k a month to sustain ourselves.

Linda Hudak also spoke about the Basic Manners class being offered as well as the next Basic class held in Pt. Orange (outside) should be starting March 30. Dance class will be starting on Sunday 1/31.

#### Report of Committees

-Ralph Orlando /Pat Dean spoke about the upcoming Tracking Trial. Entries opened in December and will close on 1/25; there is only 1 entry (there was another entry but had to withdraw).

-Lisa Liguori reported on the upcoming Agility Trial being held in 2 weeks (1/22-24). Set-up date is 1/21 at 9am and Saturday 1/16 is an equipment cleaning at the trial location (Silver Sands). There will be 5 Vendors on site the weekend of the trial as well as FastCat running in conjunction to our trial. Lisa wanted to let people know that numbers are a bit down from last year (30 entries below last year) it closes on the 14th so hopefully entries will be a bit higher then. The trial is not open to the public because of Covid but there will be a viewing area around the perimeter for those participating and volunteering. Covid practices will be in place although it's an outside event. Lisa said that there is a huge need for helpers because the groups/ organizations that had helped in the past were not participating this time because of Covid.

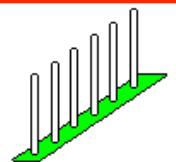
