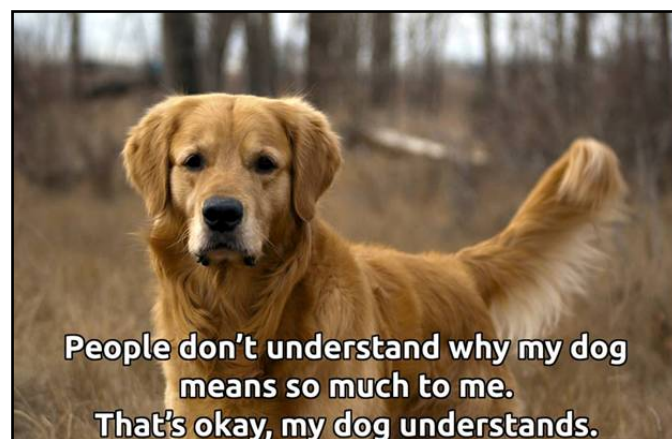

OCOD PROPOSED CHANGES TO STANDING RULES

Page 4 of 5 (9 Membership)

OLD: A. A \$5.00 late fee will be added if not paid before the first day of January each year.

NEW: \$10

OLD: B. The uppermost limits for dues shall not exceed \$75.00

NEW: (We need to match the Constitution = \$150).

NEW: C. If membership has lapsed more than 6 (six) months the late fee is \$25.

SAME D: If membership has lapsed more than 1 year, it is a new membership.

NEW: E. Members are required to help clean the building 1 time each 6 months to qualify for class discounts and 1/2 price Annual Banquet.

Page 5 of 5 Standing Rules) & Page 3 of 9 (Constitution) need to match

OLD: B: By Lapsing: A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid forty-five (45) days after the first day of the calendar year, however, the Board of Directors may grant an additional ninety (90) days to delinquent members in meritorious cases. In no case may a person be entitled to vote at any Club meeting whose dues are unpaid as of the date of that meeting.

NEW: B: By Lapsing: A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid for 1 (one) year.

NEW: C: Dues are payable on or before the first day of January of each year. No member may vote whose dues are not paid for the current year. During the month of November, the Treasurer shall send to each member a statement of dues for the ensuing year by Chatter-Barks newsletter and/or electronic mail. However, the Board of Directors may grant an additional ninety(90) days to delinquent members in meritorious cases. They shall not vote as the date of that meeting until dues are paid.

I hereby release and agree to save and hold harmless and indemnified OCOD, Inc. any Board Member, Instructors or Members or Property Owners from any and all liability, claims, suits, actions, loss, illness, injury or damage of any nature or kind, or for any liability or injury I may sustain or which may be caused in any way by me and my dog(s).

My signature also signifies that my dog(s) are in good health, and have received the necessary vaccinations (or equivalent alternatives) as agreed upon my veterinarian (copy attached). I agree to clean up after my dog or be asked to leave the premises and forfeit any classes and money.

I certify that I have read and understand the rules and regulations set forth herein and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all of the terms, conditions and statement of this agreement and confirm the truthfulness of the contents of this release form completed by me. The Obedience club of Daytona reserves the right, and option of refusing training to any dog or handler. This is to include classes, ring use, building use, and/or any club event such as seminars, tests, trials and matches. Any dog which becomes aggressive or disruptive towards other dogs or people will be dismissed. The training Directors, at his/her discretion, reserves the right to dismiss any dog from class without refund. If the dog is not under control and/or presents a danger to others, you will be dismissed from classes. Such a dog or handler may not attend any function leased to another club in the club building with written consent from OCOD Training Director or Board. A dog or handler may be dismissed "AT WILL".

In the event that OCOD, Inc. should bring suit or be sued because of any breach or violation of any rules or regulations of the Club, City, county or for any other reason based upon the action of the Member or for other relief against Member, declaratory or otherwise, or should OCOD, Inc. prevail in any such suit or should such suit be settled in favor OCOD, Inc. Member agrees to pay OCOD, Inc. all costs, expenses and reasonable attorney's fees that OCOD, Inc. may have incurred in connection therewith, which shall be deemed to have accrued on the commencement of such suit and shall be enforceable whether or not suit is prosecuted to judgement.

Report of the Board of Directors:

Item 1. Three (3)shop vacs will be purchased by Claire Israelson to replace the upright vacuums.

Item 2. Renewal policy on the Fidelity Insurance for the new term has been approved.

Item 3. Donations for the 2019 year will be for Sophies Circle. The Board will decide on a second facility/org. at a later time. Suggestions welcome.

Item 4: Large copy machine will remain with Pat Mozden until after the spring Dancing Dog show program has been put together. Copies for Basic class homework will still be run off or sent electronically. Certificates that are given out for the Puppy & Basic class- Supply is good for now.

"CDSP" COMPANION DOG SPORTS PROGRAM

CLASS: March 15 & 19, April 12 & 26 2020 Instructor Kris Davenport

CDSP is accessible to most dogs and handlers. Handlers are allowed and encouraged to praise their dog during most of the exercise. The handler may even give a small treat at the end of the exercise. Yes, in the ring! This venue is a more relaxed atmosphere and thus a great way to start competition.

In order to enter a compete on trial you MUST have a number from CDSP. It can be done on line at www.companiondogsportsprogram.com—quick and easy on line! Dogs 6 months or older—purebred, mixed breed and even dogs with disabilities. As long as the dog is not in any pain he/she may compete. Veteran dogs can continue to enjoy competition jumping at lower heights. The class will incorporate Starter Novice thru upper levels as needed.

Note that Starter Novice is on lead Heeling, Figure 8, Stand, and only 1/2 ring Recall and Sit/Stay
