# General Meeting Minutes

April 12, 2021

Meeting was called to order at 7:03pm by Linda Hudak, President

Sign in sheet was passed around 20 members were present and 1 guest.

Wins and Brags were announced. Ralph had a big list of OCOD members that went to a trial at ODTC in Orlando. Our teams walked away with lots of wins and titles. The information will be sent to Joan's e-mail as well as any other Wins and Brags to be posted in Chatterbarks.

Guests were asked to introduce themselves and were welcomed.

Minutes of the last meeting were not read but were published in Chatterbarks.

Report of the Secretary: We have 3 new membership applications: 2 memberships were read at the meeting. Brian Bender, yellow lab, SM PC, and Melanie Bivens Reagan, Samoyed, SM PC. One membership was signed after the meeting and I was given permission to count this member as an April membership also. Patty Mills, and Milo her Bordoodle, DB HM. Welcome to our new members. No other correspondence.

Report of the Treasurer: Renee brought us up to date on our Bank accounts.

Report of the Board of Directors: Pat said we are looking into a number of items that we need information on. With the Realtor we have put in writing that we intend to exercise our right of first refusal to purchase the building for \$325,000. We are going to have a very detailed inspection that will be done in a couple of days. It appears that we will not be able to get an appraisal in a timely manner. By the time we would get one it would be several weeks out and it wouldn't change the price of the contract anyway. We have been to visit an attorney and Todd who is a Realtor has been able to point out some discrepancies in the paperwork. Things are coming along. This is certainly not a done deal yet. The mortgage will be held by the owner for ten years. There will be no pre-payment penalty. The monthly mortgage payment will be about \$2,200 with an addition of condo fees for our building in the neighborhood of \$1,300. Once we are owners we need everybody to step up and help with classes so that we can pay the bills and keep the doors open. Joan will put another request for Instructors and assistants in the Chatterbarks. Joan has lots of people on her waiting lists for classes.

Linda Brendlinger will be mass e-mailing from Linda Hudak to the members so please check your spam files for e-mails from Linda Brendlinger and Linda Spirit while this e-mail change is getting started.

May 8th, and 9th ... K-9 Jacksonville Club will be renting our building for their Obedience and Rally Trial. We will be having a cleaning day before the trial. Props, crates and other personal items will have to be removed from the training center if you're not in the trial. Ralph and Linda Hudak had a discussion about how many rings they would be renting. Linda will check her paperwork at home.

OCOD needs a new scrubber for our floors. Claire has done a lot of research and has found a disc, walk behind scrubber that is self propelled and very user friendly. It cleans better than our riding scrubber. It has less chance of machine error or human error. We have invested a lot in these mats and they are very expensive. They will last a long time if we take care of them. Burns Supply gave us 1/2 the original price of our current scrubber toward the cost of the new one plus they are also paying 1/2 of our sales taxes on the purchase. This will bring our total out of pocket to \$4,870.34. Joan made a motion to purchase the scrubber,

Anna seconded the motion. There was a unanimous yes vote to purchase. Claire will have the Pacific company training rep come as soon she has given Burns Supply the check. Claire will be happy to train others how to operate the scrubber after it is delivered. The arrival of the furniture for our front desk area is on hold for now. The furniture won't be coming until after the trial in May. The Scentwork trial dates are not on the schedule yet. We are continuing to look into paypal for those that want to use the service. We will continue to accept checks, money orders and cash for payments.

Linda Hudak and Todd will be touching base and getting a training committee together. The committee will be looking over our current curriculums and possibly updating some of our programs.

A very detailed inspection on the building will be this Wed. morning and there will be Board members here to watch the inspection. There was a question about if we were going have any classes on CGC Urban. Linda Hudak said we do have a CGC prep class but it does not include Urban. Joan said we are going to have CGC testing at the training center on Sat. April 24th from 12-1 which will cost \$10 for members and \$20 for non-members. Renee says we do the testing here for Urban outside the training center. Advanced CGC testing is done inside.

Report of Committees: Ralph came to the mic to say he had some nice pins with different dog breeds that Joan had made some time ago and had given them to him to put out to get donations for the military dogs. He also was explaining to the members that there is a memorial K9 Statue Program for the County that he is raising money for. He doesn't have a drawing of the statue yet and is hoping to get the donation amount to \$2,500. The K9 Memorial Statue will be placed at the training facility on Tiger Bay Rd. just off of 92 inside of the gate. Ralph talked to the people out there that run the program for the county and he said right now we are the group that has raised the most money.

New Business: July 10th we have the eye clinic coming up. If you're interested in going to it send in your money soon because there is a limit to the number of dogs they can take. Our Club's trial is July 16 for Rally, and the 17th and 18th for Obedience. The revised Premium is already on our website. In Aug. we are renting the building out for the Mid Florida Golden Club. We still have our ring rental on Saturday. Everybody is welcome. Joan please send out info on teeth cleaning. Ring rentals are not just for competition people. You can always bring your dog in for socialization. They will learn to enjoy being comfortable in a different environment. Wednesday before an upcoming trial, we will have ring rentals for people that want to practice in our facility. Matches prior to the trial would be a great way to bring in additional funding for the club. It takes a village to pull these matches off. Linda Hudak says don't hesitate to send her e-mails with suggestions. Linda Campagna wanted to let the members know she was starting a Canine Freestyle Beginners and an Advanced Beginners dance class on Sunday afternoon the 25th of April. She said it's a wonderful 7 week class and a lot of fun. Twenty years ago Renee came up with the winning name for our dance group which is called the Canine Fancy

Dancers and Joan designed the logo for our group. Linda Hudak asked if anyone does fastcat anymore. Marks place has fastcat from 7:30pm to 10pm every Saturday unless the weather is bad. Joan

Costello made a motion to adjourn. Linda Hudak thanks everyone for coming out.
