Meet Smokey, AKC Therapy Dog Supreme By Ralph Orlando

Liebchen's Smokey Bones Mountain Mischief is known to most as "Smokey." Training began with Smokey in the puppy class at the Obedience Club of Daytona, and his first award was the AKC S.T.A.R. Puppy. We went on to more advanced obedience and rally classes and titles.

Smokey is a friend and family member and in addition to the AKC Therapy Dog Supreme title, together we have earned the VCD2, UDX, PUTD, BN, VER, RM, TDU, MXP, AJP, OFP, SIN, SHDN, THD, DJ, CGCA CGCU, and TKA.

Smokey and I volunteered at the Halifax Hospital Psychiatry Unit (Daytona Beach, FL) every other Tuesday for 11 ½ years. In the last 6 years, other areas of the 2building facility have opened for our visits. Before COVID, Smokey was invited to Friday visits to Emory L. Bennett Veteran's Home, and as of March 2023, two nursing homes and the Veteran's Home are back on our schedule.

We now also visit Embry-Riddle University with three or so visits during the highstress hectic school year to help ease the tension a bit for the students, and we volunteer at the Humane Society summer camp as well a summer camp for children at the Drive-in Christian Church.

I have been a Tester/Observer for the Alliance of Therapy Dogs (formerly Therapy Dogs Incorporated) since 2014 and Smokey has helped me by serving as the neutral dog. His laid-back presence has a calming effect on the teams being tested, and I am grateful to have him as a partner.





OBEDIENCE CLUB OF DAYTONA GENERAL MEETING

April 10, 2023

President Michele Lemole welcomed everyone and thanked them for coming even in this terrible weather. She said this month we have a very special guest who is going to talk to us. This is Tammy and her Bloodhound Beau who is actually in our Foundations to Agility class on Monday evenings. Tammy also trains dogs and she is working with Beau on some specific things that Bloodhounds do. She is going to talk to us this evening about Bloodhounds and some of the training that she is doing with Beau.

Tammy started by saying she gets asked a lot if he is a Basset hound, Great Dane, or a Mastiff. She was originally saving up for a Malinois when I took a really hard left and ended up with a Bloodhound. I got a dog that was a lot harder to train and three times the size. He does agility, dock diving, fast cat, and he is her service dog for social anxiety. They are also doing search and rescue for Central Florida. Tammy thinks Beau is a Malinois in a Bloodhound suit because he is very motivated. They are built to work. He does a little bit of bite work for fun. Trailing is what Bloodhounds were meant to do. There is a big difference between tracking and trailing. Tracking is mainly focused on fresh ground disturbance and also human scent. Tracking is all on the ground. If your dog is tracking you don't want the dog to lift his head away from the ground. If she were to send Beau out trailing he would be looking for her. If he were trailing he would be looking for a specific scent. If others were in the same area he would pass them all by and keep looking until he found the right person. If you went missing they will collect your scent on the arm rest or steering wheel cover of your car or from any personal items you may have worn or items your feet have touched. If you send a dog out for tracking you want the dog to not lift his head off the ground. Tracking dogs are nose to the ground for 24/7. Bloodhounds work smarter so if you send a dog out for trailing they will also use air sensing. Breeding plays a lot into how effectively your dog can trail. The whole composition of the dog has to do with how effectively your dog will work. Beau has lots of face wrinkles, long floppy ears and big old jowls. When he goes to trail his nose will be on the ground and all of his facial folds will fall forward which helps them to focus on the scent. Beau is also a very good companion. Bloodhounds are prone to ear infections and also Beau's beautiful dewlap is prone to yeast problems. Bloodhounds also make a good service dog to work with Autistic children. Tammy belongs to a not for profit Search and Rescue volunteer organization. They are always looking for more "Life find dogs" so please contact her if you would like more information. Beau has been trained to be a "Life find dog" and if police agencies need their help to find someone they contact the group which goes out to help if they can. When trailing Tammy worries about snakes, ticks, bears, and covotes. She believes in vaccinating for Lyme She never goes out on her own and always has both a human and dog first aid kit disease. available. Tammy also said how agile and fast Beau was in agility and how he had a lot of muscle in his back legs and neck. Michele thanked everyone for coming out to the meeting and thanked Tammy for the wonderful presentation. Michele said we love having Beau in our class and he is fast as lightning running for his ball.






Sincere Sympathy to Linda Stites on the loss of her husband Ray
