### OCOD RALLY & OBEDIENCE TRIALS

Our summer trials will be held on July 16-18, 2021. On Friday July 16 will be back-to-back Rally trials with AKC Judge Brenda Critelli running the show. This trial will begin at 8 am on Friday.

Then on Saturday again back-to-back trials with judges Linda Unger judging Novice and Luci and Ron Seeley judging Open and Utility for a total of 3 trial each over the weekend.

It is usually a challenge to get a full staff of stewards to step up and volunteer but this time even at this early date the events are almost fully staffed. Just tonight I had a new club member volunteer to steward not really knowing the job at hand.

She is presently enrolled with her dog in an intermediate class. I assured her not to worry and that with minimal training she would be fine with stewarding in the Novice Class. I think the experience will give her a good look at trialing and build the confidence to try it before too long with her dog. Of course, taking Novice training would be her next step toward that goal.


Normally prior to our trials we have a match on the Saturday before but this year there is a conflict on that day with another club activity so the match if we have one this time must be on another day. A Match is a run through to practice what you could expect in the actual trial but with a make-believe judge (usually an experience club member) playing the role of the judge.

As you most likely have noticed the floors are boxed off in 6ft X 6ft squares for social distance spacing and the plan is to leave them in place even though the CDC guidelines have been relaxed. These boxes will keep the crating much more organized and make it much easier for exhibitors to find a crate spot without feeling like they are intruding on someone else's space.

### Obedience Club of Daytona General Meeting Minutes May 10, 2021

Meeting was called to order at 7:01pm by President Linda Hudak. (Lisa Liguori speaker on Barn Hunt )

Sign in Sheet was passed around - 18 members were present and there were no guests.

Minutes of the last meeting were not read but were published in the Chatterbarks.

Report of the Secretary: We have 3 new Membership applications: Lynn Betournay (S) Lake Helen, Tammy Ryan (S) Edgewater, and Charles & Theresa Myers (Household) Oak Hill

Report of the Treasurer: Renee brought up the fact that we have had very nice donations coming in for the building fund to be used toward the down payment. She said "we love to have people give us money" .

Linda Hudak wants everyone to know it doesn't matter how large or how small the donation is. The inspection came back and there were no great surprises the building was constructed in 1967. When you purchase an older building you will have to do maintenance and repairs over time and the building fund will not only help us pay the mortgage off earlier but it will also help us with upkeep of the building.

Report of Committees: Lisa Liguori says agility classes at Silver Sands are on break right now do to the heat. Foundation classes will be held at the training center on Thursdays at 6pm in the air conditioning. There are some openings still available. The pre-requisite would be that your dog would have graduated Basic Training any questions just call Lisa.

Ralph was reporting on our trial held here by Jacksonville Club. He said it went really smooth with rings 1&2 used for the trial, ring 3 was available for warm up's for a small donation and rings 4&5 were used for crating. We got box lunches for the Judges from Publix. They are really nice and only 7-9 dollars. The restaurant in the parking lot is probably out of business. Our July trial will have Rally on Friday, two regular classes of obedience on Saturday, and a single class on Sunday. The K9 memorial for Volusia County Sheriff estimates the cost at 6-7 thousand dollars which they have in their fund and we have raised \$1,900 plus another \$1,000 from the military fund so Ralph thinks we will get a lot of recognition for such a large donation.

Renee said our refrigerator was unplugged and this has happened before so we are going to put a sign up. Pat Mozden said her husband Jim was in maintenance for the school system for many years. Jim is an expert in lighting. She said we can save money to do it ourselves and we can phase the repairs in over- time as the budget allows. Pat and Anna volunteered to be Jim's assistants. 🤤 Yea Team

Linda Hudak wants us to make sure we are careful about leaving unnecessary lighting on if we are not working in that area. She would be happy to show us where all the lighting switches are in the rear of the building. Linda Hudak wanted to thank everyone who stayed to help clean up after the trial.

Lisa Liguori talked about Barn Hunt and explained that it is open to most dogs. Barn Hunt is presently not an AKC sport it's done through BHA (Barn Hunt Association). She is getting ready to start the classes for the various stages of Barn Hunt. She talked about the design of the special holders for the rats that are humane, and gives them protection from the dogs. There is a lot to learn about the different categories and levels when you compete for titles. Videos and information are plentiful on the internet. To get started call Lisa.
