Ruth Andrick and "Tanner" earned a leg in Preferred Novice and a 1st Place Win on 7/17/16 at OCOD Trials.

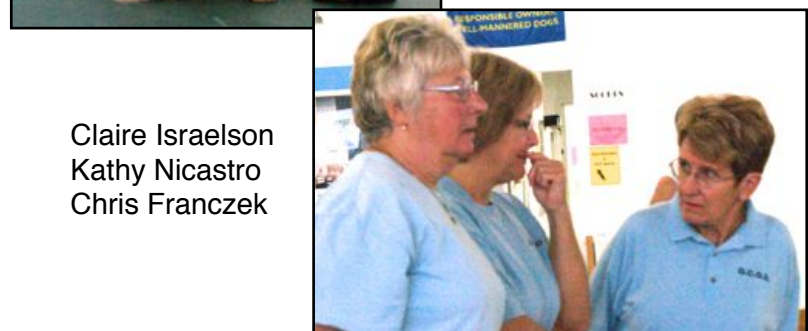
