

#### New Business:

- Pat Mozden wants to remind the membership that on Tuesday the pet hotline will be on TV brought to us by Daytona State College at 7:30 pm.
- Pat Mozden wanted to go ahead and prepare everyone that Responsible Dog Owner Day will take place again this year, Kathy Nicastro is nice enough to help run it this year it will be the 1st Saturday in September.
- It is the time of year for our donations this year we will be donating a bullet proof vest to a Port Orange Police dog by the company Vested Interest in K-9s which will cost \$950. The club will also be donating to Sofie's Circle, Arnie & South East Humane Society each place will receive \$325. This was put to a motion by Janet Berry and 2<sup>nd</sup> by Kathy Nicastro.
- There was a motion made to permit Pat Mozden to investigate the new Ormond ordinance for \$100,000 dog liability insurance, she will investigate and clarify this for the club.
