

#### General Meeting Minutes

February 13, 2017

Meeting was called to order by Pat Mozden at 7:00PM

Guests: Patricia Dean, Claudia and Briana Soulie

Sign in sheet was passed around and is attached to hard copy of minutes

Wins and brags were announced. Joan announced that this month, she is officially a lifer. Be sure to send your wins and brags to her for the newsletter.

Pat requested that we all refrain from talking to each other during the meeting so that we can all hear what is happening in our club.

Minutes of the last meeting were published in the newsletter and so were not read at the meeting.

Report of the secretary: We have 4 new single and 2 household memberships: Patricia Dean, Tara Denehy, Donna Hogan, Laura Sconyers, Paula and Mike French and Claudia and Chris Soulie.

Report of the Treasurer:

Expenses: \$17,394.16

Income: \$30,849.21

Report of the Board of Directors:

Quickbooks: board authorized purchase for treasurer's use.

Program speakers: need someone to set up speakers for meetings. Linda Eastlake will try to get a Ravenwood vet to speak on canine dental health for March. Let Pat know of any other ideas.

Puppy and basic instructors: we need new instructors and will be encouraging assistants to become instructors. We have lost a number of instructors and classes are filling up months in advance now.

Raffle baskets: Yvonne will spearhead a group to take over the raffle baskets for the July trial and we'll see how that goes for future trials. Donations will be stored upstairs, but the donations box will remain downstairs and we may hold basket making parties. Anna will be asked for guidance to transition this to Yvonne. We may ask local businesses to donate things for baskets.

Snake Clinic: may be held this year since there seems to be a high level of interest.

Agility trial: Pat led us in applause all around for another successful agility trial.

New Business:

Agility FAST flags: Ralph has 2 sets of flags for sale since we have switched to the little white signs for trials. Maria will post an announcement on FB in hopes of selling them to another club. New cost is approximately \$300.

Mats: Ralph announced we still have some 35' and 50' green rolls of matting for sale.

New flooring: The manufacturer will be in tomorrow between 3 and 6PM and Ralph will check with her regarding the ripples we notice at the seams. Is it normal or does something need to be done about it.

Tracking tests: We had 3 TDU and 4 TD exhibitors at the tests and 2 passed. Ribbons were awarded for the first time. In the past only the signed glove was awarded.

Committee Reports:

Training Director: Reneé requested that we keep alert and make sure we follow the lockup process before leaving the building. A few reminders include - make sure to turn off the radio before leaving, lock both doors including the puppy door even if no one supposedly used it, put all ring gating back to the standard configuration if it has been moved for any reason. We need to keep an eye on all our dogs to be sure they do not pee in the building while we stand around talking or doing other things. The front door area seems to be especially enticing to dogs. Puddles found have been small, but we all need to be more vigilant about this. Water in the refrigerator is 50 cents a bottle. Please be sure to leave cash either in the box in the fridge or the box up front.

MWD: Ralph reported he has contacted a Navy kennel that has a long list of needs, in particular they need 10 dog cots. He will present a program at the April meeting about the Military Working Dog effort.

Trial ribbons: Marge reported she was able to get quite a discount on ribbons by ordering early for both the July and December trials.

Public Education: Pat announced we are only doing partial day events and that should make it easier for more members to attend and support the club. Joan reported that both PetCo and PetSupermarket have been recommending our classes to their customers.

Shirley motioned we adjourn, Reneé seconded at 7:41PM.
