

Changes to the Standing Rules

As Written:

4. **INSTRUCTORS WHO TEACH** any class are eligible for CLUB DOLLARS, equal to the member amount charged for the class. There will be only one full instructor per class and assistants as needed.

Higher Class Instructors earn ring time, .ie: Open, Utility, UDX, etc

- a. Obedience Assistants receive 1/2 the club dollars for club price classes ie. 7 week \$40 class = \$20 club dollars
 - b. Agility instructors and assistants receive full credits as earned per class
 - c. Once Club Dollars are assigned they are non-transferable except within immediate family memberships
 - d. Once Club Dollars are assigned they cannot be replaced if lost
 - e. Club Dollars may be used as determined by the Training Committee
 - f. Past seminar credits may be used for OCOD held seminars for Audit Spots

NEW:

- INSTRUCTORS & ASSIGNED ASSISTANTS WHO HELP any class are eligible for CLUB DOLLARS, as
 defined by the Training Committee, and subject to change as necessary. Club Dollars are equal to the number
 of weeks for the class.
 - a. There will be only one full instructor per class and assistants as needed.
 - b Obedience Assistants receive 1/2 the club dollars as the Instructor. for club price classes ie. 7 week
 - c. Agility instructors and assistants receive full credits as earned per class
 - d. Once Club Dollars are assigned they are non-transferable except within immediate family memberships
 - e. Once Club Dollars are assigned they cannot be replaced if lost
 - f. Club Dollars may be used as determined by the Training Committee
 - g. Seminar Credits can only be earned by a FULL INSTRUCTOR
 - h. Seminar credits may be used for outside seminars related to club policies and OCOD held seminars for Audit Spots only

Rebuttal to Janet Narushka's Letter to the Club:

The 4 to 6 page letter Janet Narushka read to members and guests at the April meeting was very one sided in her favor, and

did not tell the entire story.

For the past 18 months, the Board has stood by their decision that for the safety of our students and their dogs, Janet's friends dog, Aiden, is not permitted to attend classes in our facility. Janet keeps bringing up the matter. The Board recently reviewed her case for the second time, and Janet is not happy with the Board's decision to continue to ban the dog.

The OCOD Instructors refuse to have the dog in classes, and the students refuse to come if the dog is in class.

The dog was tested by a dog behaviorist, Edd Gordon. According to Edd, a person that testifies in court cases, "the dog should not be in a class situation". Janet and the owner picked the behaviorist, and now say he does not know anything.

Janet has been give permission to train the dog as a one on one in our facility when no one is there. She was recently found at a Monday night class situation and asked to leave. She would not take the dog from the building and had to be threatened with police action.

Who's conduct is in question here, the Training Directors or someone who is an AKC Judge as well as an AKC Delegate, and should know better? She has even threatened to try to stop our July Trials. Both Training Directors and the Board stand by the decision to ban the dog from classes. Renee Johnson

Also coming up is the biggest public outreach day of the year in August, it is Responsible Dog Owner Day at the Volusia Mall. Also the club supports the Hush Puppy organization that is for dogs that have to move because of spousal abuse they need anything from crates to blankets.
- Ralph Orlando would like to announce he has risen over \$2500 for the war dogs.

In front of new members and guests, she accused the club of being more interested in making money than caring about people and their dogs.

Janet stated that AKC expects clubs and club members to follow good sportsmanship. She then said that she is "Demanding a Written Letter of Apology." Janet cautioned the club that if this matter wasn't settled that we were putting our future trials at risk.

President Joan Costello requested that Janet Narushka submit a copy of the document that she read to the membership to the Board for our records.

The meeting adjourned at 8:24pm with a motion from Claire Israelson, 2nd by Jean Van Horn.
